1. All bids are due by 11:59:59 p.m. on July 24, 2022.
2. All bidders must be 18 years of age or older (or the age of majority in the bidder's state of residence).
3. The highest bidder will be deemed the winning bidder.
4. The winning bidder will be notified the week of July 25, 2022 by telephone at the telephone number provided at the time of placing the bid, and by email at the email address provided at the time of the bid.
5. Hy-Vee shall not be responsible for suspended or discontinued wireless, land line or online service or undeliverable emails, which may result in a potential winning bidder not receiving the winner notification.
6. The potential winning bidder will be required to respond as directed in the winner notification within twenty-four (24) hours of the time the winner notification is sent and/or made, or the auction item will be forfeited and may be awarded to the next highest bidder, in Hy-Vee's sole discretion.
